TERMS AND CONDITIONS FOR CELCURE TREATED TIMBERS

## **TERMS**

Working in co-operation with Osmose, we are implementing quality procedures that will enable Premier Forest Products Ltd. to produce Timbers that carry a 5 year Service Life Guarantee.

This Guarantee is purely for the Cost of re-supply by Premier Forest Products Ltd., of a component that is proven to have failed as a result of Fungal Decay or Insect Attack, not Weathering of Timbers.

This Guarantee does not cover the Costs of removal or reinstatement of such components, or consequential Costs or loss due to failure of the component.

The Term "Failed" as used in this Guarantee refers to damage caused by insects and/or fungito such an extent that the component is no longer fit for purpose.

The Terms "Fungal Decay" and "Rot" as used in this Guarantee mean attack by Timber destroying fungi that disintegrate the Timber cell walls, but do not include staining fungi associated with the "Weathering" of Timber. "Weathering" of Timber is not fungal decay or rot of any type or definition, but is purely the natural process of discolouration due to the Timber being exposed to the natural elements.

The Term "Insect Attack" as used in this Guarantee refers to attack by Timber destroying insects that destroy the Timber Structure, such as termites.

## **CONDITIONS**

Should the Premier Forest Products Ltd. Celcure Treated Timber be Bored, Cross-Cut, Notched or any other Machining Process during installation, then any exposed surfaces must be coated with a suitable end coat preservative, administered to the correct application procedures.

Should any Machining Process take place and a suitable end coat preservative not be available, all relevant Timber must be returned to Premier Forest Products Ltd. for ReTreatment.

## **EXCLUSIONS**

These Terms and Conditions do not apply to :-

- i) Any Premier Forest Products Ltd. Celcure Treated Timbers supplied for use outside of European Markets.
- ii) Any Premier Forest Products Ltd. Celcure Treated Timbers removed from their original installation and re-used at a new Location.
- iii) Damage caused by "Weathering" of Timber, including but not limited to Cracking, Shrinkage, Splitting, Swelling, Twisting or Warping, or any other physical property of the Timber where untreated Material is exposed to the effects of this "Weathering".
- iv) Timber degrade which is the result of the natural movement of Timber in service, including "Weathering", "Twisting" and "Splitting" of components.
- v) Celcure Treated Timber that is Machined in any way after preservation, unless the exposed area has been treated with a suitable end coat preservative.
- vi) Areas of Timber where preservative surface penetration is consistently restricted to less than 3mm or is effectively unachievable due to natural variations in the property of the Timber and/or abnormal growth characteristics.
- vii) Mould growth on treated Timber products.
